Terms & Conditions

Our venue hire charge, covers the use of the venue from 7pm-11pm. If you wish to book the venue earlier, this will incur additional costs which can be discussed prior to booking. We require all guests to have vacated the building by 12am.

As our sites are located in residential areas, we ask that all guests are mindful of this when arriving & leaving the venue.

A deposit of 25% of the total fee will be required to secure the booking.

No booking will be made or deemed valid without payment of the deposit by bank transfer, debit or credit card.

The full invoice will need to be settled on the day of the event.

A service charge of 10%, based on the total invoice, will be added.

In the event of a cancellation, the deposit will be non-refundable if cancelled within 7 or less days to the event. Cancellations should be made by email to info@generalmerchants.co.uk or by telephone, 02890291007.

The final guest count for food will need to be confirmed, at the latest, 7 days prior to the event. If the guest count reduces within the 7 days, you will be charged at the agreed count.

If more guests need to be added within the 7 days, please notify us by email or by telephone. Additional charges will be made per additional person.

All bookings are on the proviso that each individual in your group are consuming food.

It is the responsibility of the applicant to confirm any allergens or dietary requirements prior to the event.

For food safety and allergen reasons, we require notification of any intention to bring food from external sources. (ie birthday cakes)

For our Antrim Road & East Belfast, our premises are B.Y.O.B and corkage is reflected in the venue hire.

Persons under 16 years of age are only permitted onto the premises on the understanding that they are with a parent or guardian who accepts full responsibility for their safety, welfare & behaviour.

No intoxicating liquor may be consumed by any person under the age of 18 years, the applicant will be held responsible for compliance with this condition.
